INDEPENDENT AUDITOR'S REPORT FLORIDA A & M UNIVERSITY DEVELOPMENTAL RESEARCH SCHOOL FULL-TIME EQUIVALENT (FTE) STUDENTS

We have examined management's assertion, included in its representation letter dated April 16, 2007, that the Florida A & M University Developmental Research School complied with the State requirements governing the determination and reporting of the number of full-time equivalent (FTE) students under the Florida Education Finance Program (FEFP) for the fiscal year ended June 30, 2006. These requirements are found primarily in Sections 1011.60, 1011.61, and 1011.62, Florida Statutes; State Board of Education Rules, Chapter 6A-1, Florida Administrative Code; and the *FTE General Instructions* issued by the Department of Education. As discussed in the representation letter, management is responsible for the School's compliance with State requirements. Our responsibility is to express an opinion on the School's compliance based on our examination.

Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants and the standards applicable to attestation engagements contained in *Government Auditing Standards* issued by the Comptroller General of the United States and, accordingly, included examining, on a test basis, evidence about the School's compliance with the aforementioned State requirements and performing such other procedures as we considered necessary in the circumstances. We believe that our examination provides a reasonable basis for our opinion. The legal determination of the School's compliance with these requirements is, however, ultimately the responsibility of the Department of Education.

In our opinion, the Florida A & M University Developmental Research School complied, in all material respects, with State requirements governing the determination and reporting of the number of full-time equivalent (FTE) students under the Florida Education Finance Program (FEFP) for the fiscal year ended June 30, 2006.

The results of our examination disclosed instances of noncompliance with the State requirements mentioned above. We considered these instances of noncompliance in forming our opinion regarding management's assertion and these items did not affect our opinion as stated above. All of the instances of noncompliance disclosed by our examination procedures are discussed in SCHEDULE D. The impact of those instances of noncompliance on the School's reported number of full-time equivalent (FTE) students is presented in SCHEDULE A, SCHEDULE B, SCHEDULE C, and SCHEDULE D.

This report is intended for the information of the Legislative Auditing Committee, members of the Florida Senate and the Florida House of Representatives, the State Board of Education, the Department of Education, and the Florida A & M University Developmental Research School. Copies of this report are available pursuant to Section 11.45(4)(c), Florida Statutes, and its distribution is not limited.

Overview

Management is responsible for determining and reporting the number of full-time equivalent (FTE) students under the Florida Education Finance Program (FEFP) in compliance with State requirements. These requirements are found primarily in Sections 1011.60, 1011.61, and 1011.62, Florida Statutes; State Board of Education Rules, Chapter 6A-1, Florida Administrative Code; and the FTE General Instructions issued by the Department of Education. The Florida A & M University Developmental Research School complied, in all material respects, with State requirements governing the determination and reporting of FTE for the fiscal year ended June 30, 2006. All of the instances of noncompliance disclosed by our examination procedures are discussed below and require management's attention and action, as recommended on page 8.

Findings	Adjustment (Unweighted FTE)
Our examination included the July and October 2005 surveys and the February and June 2006 surveys. (See NOTE A5.) Unless otherwise specifically stated, the findings and audit adjustments presented herein are for the October 2005 survey or the February 2006 survey or both. Accordingly, our findings do not mention specific surveys unless necessary for a complete understanding of the instances of noncompliance being disclosed.	
1. [Ref. 35101] The course schedules for three students in on-the-job training	
(OJT) were reported using an incorrect priority that funded the students' off-campus	
OJT courses prior to their on-campus instruction. We also noted that the timecards for	
these students were missing and could not be located. We made the following audit

Recommendations

We recommend that management exercise more care and take corrective action, as appropriate, to ensure that: (1) the on-campus instruction of students is funded prior to any off-campus instruction or work time; (2) timecards for students in OJT programs are properly completed and retained in readily accessible files; (3) teachers are properly certified or, if out-of-field, are approved by the School's advisory board to teach out-of-field; and (4) the parents of students taught by out-of-field teachers are appropriately notified of the teachers' out-of-field status prior to the survey period.

The absence of statements in this report regarding practices and procedures followed by the School should not be construed as acceptance, approval, or endorsement of those practices and procedures. Additionally, the specific nature of this report does not limit or lessen the School's obligation to comply with all State requirements governing full-time equivalent (FTE) students and the Florida Education Finance Program (FEFP).

NOTE A - SUMMARY

A summary discussion of the significant features of the School, the Florida Education Finance Program (FEFP), full-time equivalent (FTE) students, and related areas follows:

1. Florida A & M University Developmental Research School

The Florida A & M University Developmental Research School was established pursuant to Section 1002.32, Florida Statutes, as a developmental research school on the campus of Florida A & M University. The statute specifies that developmental research schools are to provide "a vehicle for the conduct of research, demonstration, and evaluation regarding management, teaching, and learning." The statute also states that "the primary goal of a lab school is to enhance instruction and research in [mathematics, science, computer science, and foreign languages] by using resources available in a state university campus, while also providing an education in nonspecialized subjects." The School offers instruction in Basic education and Career Education 9-12, and serves students in kindergarten through twelfth grade. For the fiscal year ended June 30, 2006, the School reported 459.1668 unweighted full-time equivalent (FTE) students, and received approximately \$2.7 million in State funding for those FTE under the Florida Education Finance Program (FEFP). The primary source of funding for the School is State funds allocated from the Florida Education Finance Program.

2. Florida Education Finance Program (FEFP)

Florida school districts and developmental research schools receive State funding through the Florida Education Finance Program (FEFP), which was established by the Florida Legislature in 1973. It is the intent of the law "to guarantee to each student in the Florida public school system the availability of programs and services appropriate to his educational needs which are substantially equal to those available to any similar student notwithstanding geographic differences and varying local economic factors." To provide equalization of educational opportunity in Florida, the FEFP formula recognizes (1) varying local property tax bases, (2) varying program cost factors, (3) district cost differentials, and (4) differences in per student cost for equivalent educational programs due to sparsity and dispersion of student population. 3. Full-Time Equivalent (FTE) Students

The funding provided by FEFP is based upon the numbers of individual students participating in particular educational programs. A numerical value is assigned to each student according to the student's hours and days of attendance in those programs. The individual student thus becomes equated to a numerical value known as an FTE (full-time equivalent) student. For example, for kindergarten through third grade, one FTE is defined as one student in membership in a program or a group of programs for 20 hours per week for 180 days; for grade levels four through twelve, one FTE is defined as one student in membership in a program of programs for 25 hours per week for 180 days.

4. <u>Calculation of FEFP Funds</u>

The amount of State and local FEFP funds is calculated by the Department of Education by multiplying the number of unweighted full-time equivalent (FTE) students in each educational program by the specific cost factor of each program to obtain weighted FTEs. Weighted FTEs are multiplied by the base student allocation amount and that product is multiplied by the appropriate cost differential factor. Various adjustments are then added to this product to obtain the total State and local FEFP dollars. All cost factors, the base student allocation amount, cost differential factors, and various adjustment figures are established by the Florida Legislature.

5. FTE Surveys

FTE is determined and reported during the school year by means of four FTE membership surveys. Each survey is a sampling of FTE membership for a period of one week. The surveys for the 2005-2006 school year were conducted during and for the following weeks: survey one was performed for July 11-15, 2005; survey two was performed for October 10-14, 2005; survey three was performed for February 6-10, 2006; and survey four was performed for June 12-16, 2006.

6. Educational Programs

The Florida Education Finance Program (FEFP) funds ten specific programs under which instruction may be provided as authorized by the Florida Legislature. The general program titles under which these specific programs fall are as follows: (1) Basic; (2) English for Speakers of Other Languages (ESOL); (3) Exceptional; and (4) Career Education (9-12).

Response to Citation:

The binder containing the documentation for the three 2006-2007 OJT/DCT students identified in the audit was misplaced by the instructor at the end of the year. Additionally, copies of the records were not properly maintained. Although the instructor was able to obtain verification from their former employers as to their employment, she was unable to acquire copies of the timesheets documenting actual time worked.

The school administration will institute the following measures to ensure that future OJT/DCT students' off-campus employment will be properly administered and managed.

- All OJT/DCT timesheets will be submitted to the DCT instructor as well as to the school's attendance office. These timesheets will be kept in a binder that will be constantly monitored and maintained by the principal;
- OJT/DCT students will be required to meet with the principal and DCT instructor a minimum of once per week in order to review documentation as well as discuss the DCT experience for the designated period;
- 3) The OJT/DCT instructor will contact all DCT supervisors a minimum of twice per month to verify and confirm student attendance, monitor student performance, and review the OJT/DCT experience. The OJT/DCT instructor will submit verification of these discussions to the attendance office so that documentation may be placed in students' OJT/DCT files located in the attendance office. Copies of these verifications will also be kept in the OJT/DC T instructor's files; and

4) The OJT/DCT instructor will review with the principal, once each nine weeks, the DCT attendance documents and verification documents to ensure all documentation is in order and to make any adjustments in the program as needed.

Even though the teacher was teaching out of field, he was held accountable for adhering to the state mandated curriculum.

The following measures will be strictly adhered to in order to ensure statutory compliance regarding proper and current certification for teachers of all subjects.

- 1) Teaching assignments will be based upon appropriate degrees and certification;
- All teachers will be required to have continuous staff development and proper certification prior to accepting additional teaching assignments in any subject area; and
- As required by law, the school will continue the practice of informing parents of faculty who are not teaching in field. (please see attached sample letter)
